Please accept the enclosed application as an invitation for your nomination of an individual from your business to become a member in the 2011-2012 Leadership Scott County (LSC) program. LSC is a leadership development program sponsored by the Georgetown / Scott County Chamber of Commerce. The program has been in operation since 1991 and many business, community, and government leaders have participated. The purpose of this program is:

1. To focus on specific aspects of “leadership” training and development.
2. To develop effective future leaders by providing personal access to current leaders within Scott County. Such opportunities include but are not limited to: manufacturing, government, community services, health care, history and preservation, education, etc.
3. To concentrate on “local” activities within Georgetown and Scott County to provide a greater understanding of the community’s operation.
4. To participate in a class project that will benefit the community.
5. To promote participation on community non-profit boards.

The LSC Steering Committee requests nominating individuals with the potential to become business or community leaders and will benefit from their participation in LSC.

1. Attendance is expected at every activity.
2. A participant missing 16 hours or more will not be eligible for the class trip and/or missing 16 hours or more including the class trip will not graduate from the Leadership Scott County program.
3. The LSC program seeks representation reflective of the diverse population that currently works or resides within Scott County.
4. All participants of Leadership Scott County are required to attend a minimum of one committee meeting of the five provided. The committee choices are Community Affairs, Communication & Marketing, Economics Affairs, Government Affairs, and Membership. Additional opportunities to serve on one of these committees is also an option, but not required.
5. Tuition fee of \$500.00 per person for Georgetown/Scott County Chamber of Commerce Members and \$700 for Non-Members. This covers all program costs, rooms, meals and the class trip. (Scholarships are available)
6. Please consider all factors as listed above in your decision regarding nominations.

If you are unable to make the necessary time commitments as indicated below, it may not be in your best interest to apply for Leadership Scott County at this time.

Committee Meeting: Attend at least one meeting of the five different committees within the Georgetown/Scott County Chamber of Commerce.
Class Trip: Two Days – April 12 & 13, 2012 (included in hours to graduate)
Graduation: Chamber Banquet-TBA
Class Project: All 2011-2012 LSC members must participate in a project decided upon by the class.

All dates above are subject to change. Any date change in the class trip will be communicated by October 6.
